After consultation with our legal department and given that the sponsor/applicant for the special event at the Fairgrounds on Saturday July 25, 2025 has engaged in serial misrepresentation of the event, continually contradicted by his social media promotions of the event. County staff is having to be prompted each time a new disclosure occurs, creating a scramble on the part of staff and in particular, with each new disclosure, raising ever increasing safety concerns. I support our Legal Department's recommendation cancel the permit for this event, which is revocable at will as an executive action. There is no right to appeal.
