<p>Multiple marked and unmarked Flagler County Sheriff's Office patrol vehicles activated their emergency red and blue flashing lights and attempted to block the vehicle in the parking space to prevent them from fleeing. Deputies provided multiple loud, clear and concise verbal commands for the driver and the occupants to exit the vehicle. All occupants failed to comply and refused to exit the vehicle. Due to heavy vehicle traffic within the parking lot, a small space in front of the suspect vehicle shortly appeared after a pedestrian moved their vehicle.</p> <p>The driver of the suspect vehicle who was later positively identified via Florida Driver's License as, Stevens Charles quickly accelerated through the gap at a high rate of speed without care for the safety of the pedestrians, in attempt to flee and elude from law enforcement. Stevens exited the parking lot from the Northeast exit and began traveling Westbound in the Eastbound lanes against on coming traffic on Palm Coast Parkway. Stevens then exited Palm Coast Parkway at exit 289 and began traveling southbound on Interstate 95 at a high rate of speed. A pursuit was initiated and vehicle continued to flee and elude multiple law enforcement officers.</p> <p>Stevens continued westbound on Old Dixie Highway, Deputy Prevatt deployed an agency issued tire deflation device and successfully spiked the suspect vehicles tires. Detective Dalrymple was behind the suspect vehicle in his agency issued unmarked patrol vehicle with his emergency red and blue lights activated. The suspect vehicle then violently sideswiped Detective Dalrymple's unmarked patrol vehicle causing damage to his driver side.</p> <p>Stevens approached the intersection of USHY 1 and interstate 95-mile marker 273. Stevens then began traveling northbound on the southbound exit of mile marker 273 in attempt to regain travel on Interstate 95. While doing so, Steven struck the front of a small sedan that was exiting interstate 95 causing heavy damages to both vehicles. Detective Dalrymple informed me that he observed two black males exit from the driver seat and back left passenger seat which was captured via axon dash cam. Stevens and the male in the back left passenger seat, positively identified via Florida Identification Card as, Joshua Hansen fled on foot from the crash scene into the nearby wooded area. Shortly after, both Stevens and Joshua were apprehended by deputies and nearby assisting agencies.</p>
