Probable Cause

On 09/16/2025 at/around 3:57 PM, I, Senior Corporal Gregory Reed (698) responded to Northbound Interstate 95 (State Road 9) at Mile Marker 273 (Exit for US Highway 1 (State Road 5)) in unincorporated Volusia County, Florida in reference to a fatal traffic crash.

The Sanford Regional Communication Center (SRCC) advised a vehicle, later identified as a 2025 Chevrolet Suburban (FL [REDACTED]), and it's driver, later identified as Stevens Charles (DOB: [REDACTED]) was identified via License Plate Reader LPR in a business parking lot located within Flagler County, and that said vehicle had been reported to be involved in numerous felony offenses within Saint Johns County. SRCC advised a stop attempt of the vehicle in the business parking lot was unsuccessful, and the vehicle fled the scene, traveling southbound on Interstate 95.

Flagler County Sheriff's Office Deputy Aaron Dalrymple, operating an unmarked vehicle stated to me he was traveling southbound on Interstate 95, and was passed by the suspect vehicle, activating his emergency lights / siren to signal the vehicle to stop, which the driver failed to do, accelerating speed in an obvious attempt to elude his traffic stop attempt. Deputy Austin Dalrymple was later identified by Deputies Aaron Beausoleil & Troy Magnuson, both of whom were operating marked Flagler County Sheriff's Office patrol vehicles with agency insignia prominently displayed, and lights in siren active, also attempting to order the fleeing vehicle to stop, which the driver, failed to do, continuing southbound on Interstate 95 traveling at recklessly high speed, in congested traffic, with no regard for the safety of

the motoring public, or the law enforcement officers attempting to stop him. Stevens then exited southbound Interstate 95 at Mile Marker 273, then attempting to re-enter the interstate, however when doing so, Stevens began traveling in the wrong direction, against traffic, which was exiting from Northbound Interstate 95, in the direct path of a 2017 Volkswagen sedan (FL [REDACTED]), which was traveling in the correct direction on the exit ramp, which was driven by [REDACTED] (DOB: [REDACTED]). The front of the Chevrolet impacted the front of the Volkswagen, causing catastrophic front-end contact damage to the Volkswagen, resulting in life-threatening injuries to [REDACTED].

The driver, Stevens Charles, along with two other passengers in the Suburban, identified as Rahquez Moore & Joshua Hansen, immediately exited the vehicle, fleeing the scene on foot, running into woods, all failing to render aid to [REDACTED], or halt for law enforcement after being ordered to do so, both while fleeing in a motor vehicle, and when ordered verbally to stop.

Charles, Moore, and Hansen were placed under arrest after a foot pursuit and transported for medical evaluation by law enforcement. Deputy Sheriffs from the Flagler County Sheriff's Office were actively attempting to apprehend a fleeing vehicle in hot pursuit when said vehicle entered Volusia County, and the driver / occupants were placed under arrest. Mrs. [REDACTED] succumbed to injuries sustained in this traffic crash on 09/16/2025 at 2:11 PM by Dr. Zachary Terwillger at Halifax Hospital in Daytona Beach, Florida.

Stevens Charles was placed under arrest by the Florida Highway Patrol for the following violations:

1 Count: Fleeing and Eluding a Law Enforcement Officer (Florida State Statute 316.1935(2)) for actively fleeing / attempting to elude Deputy *** with lights / siren active.

2 Counts: Aggravated Fleeing and Eluding a Law Enforcement Officer – Resulting in a Death (Florida State Statute 316.1935(4)(b)) for actively fleeing / attempting to elude Deputy *** and Deputy *** in marked patrol vehicles with lights / siren active, agency insignia prominently displayed, and while doing so, caused the death of Mrs. [REDACTED].

1 Count: Leaving the Scene of a Traffic Crash – Result in a Death (Florida State Statute 316.027(2)(c)) for fleeing the scene after being involved in a traffic crash which Charles knew or should have known likely resulted in the death of Mrs. [REDACTED].

1 Count: Felony Murder (Florida State Statute 782.04(4) for engaging in the felony offense of Aggravated Fleeing or Eluding with Serious Bodily or Death, which caused the unlawful death of Mrs. [REDACTED]

1 Count: Resisting Arrest Without Violence (Florida State Statute 843.02) for failing to stop / obey commands given by law enforcement officers previously noted at the scene of this fatal traffic crash. Stevens was remanded to the custody of the Volusia County Jail without further incident.


